PLANNING ANALYST

**DUTIES:** Under the general direction of the Land Use Bureau Chief or designee, provides planning and analytical support to assigned programs, projects, and services; conducts studies and analyses and manages projects or programs of various scope, size, budget, duration, and complexity; performs other related duties as required.

**MINIMUM TRAINING & EXPERIENCE REQUIRED**

Graduation from an accredited college or university with a Bachelor’s degree in Public Administration, Planning, Management, Economics or a closely related field and four (4) years of experience performing analytical duties which includes gathering and analyzing data including GIS, statistical and graphic software applications and formulating recommendations and report writing of which two (2) shall have been in a supervisory capacity.

*Note:* Possession of a Master’s Degree can substitute for two (2) years of the required experience.

**SCOPE OF EXAMINATION:** There will not be a written examination. Applicants will be ranked according to their education, training and experience. Applicants are advised to fully complete the application form and supplement, listing all related degrees, training and work experience. Incomplete applications or supplements will be rejected.
