**POSITION:** Reporting to the Controller, the Project Accountant – Data Analytics performs all activities necessary to ensure proper financial management and adequate internal controls for the City of Stamford, including the BOE (in conjunction with the BOE Finance Department as has been done historically). Also includes the continuous development and implementation of strong internal controls, report design and development, upkeep of written policies, procedures, and positional responsibilities as required for the Controller’s Office.

**MINIMUM QUALIFICATION REQUIREMENTS:** Graduation from an accredited college or university with a bachelor's degree in Finance, Accounting, or Business or a related field and four (4) years of progressively responsible experience in the field of financial, operational, or procedural analyses OR a bachelor's degree in an unrelated field and six (6) years of progressively responsible experience in the field of financial, operational, or procedural analyses in a governmental setting.

**NOTE:** Experience obtained in a public company or municipal, county or state government environment is preferred.
